TODD COOPER TO ATTEND MARCH MEETING! NEIGHBORHOOD PROTECTION HOTLINE...525-2525

Todd Cooper, Division Manager of the Neighborhood Protection Division of the City of Houston will be attending the upcoming APA meeting on Thursday, March 4 and will present an overview of the Neighborhood Protection project. Mr. Cooper will be informing us about the best way to use the Neighborhood Protection department and will be available to answer questions. So bring those questions, problems and concerns to the meeting and take advantage of this great opportunity to establish a rapport and begin working with this key city department to improve the neighborhood.

Neighborhood Protection teams have been formed by the City of Houston since August 1991. Instead of calling several city offices to report a nuisance, you can contact a neighborhood protection team at 525-2525. Be sure to ask for a case number.

According to information provided by the City, teams are assigned to specific zip codes to get to know the people and issues in one area. Each team has at least four inspectors who regularly check for problems in the area. They hold street by street sweeps and respond to phone calls. Specific problems handled include vacant buildings, dumping, substandard housing, rats, sanitation, tires, abandoned vehicles, and weeds.

Once a violation is confirmed, a property owner is given ten days to fix the problem. City Marshals work with the team to help enforce property laws by writing tickets, but only after the ten day period. When a ticket is written, fines start at \$250, and can go up to \$2,500 per violation. The team enforces the City of Houston Dangerous Building and Neighborhood Ordinances.

As a neighborhood association, we can work together with our Neighborhood Protection team to ensure that we use this valuable service to benefit Audubon Place. A committee is being formed to work with our Audubon Place Neighborhood Protection Team. Dave Pevear and Kathy Welch are on the committee. We would like additional volunteers to help. HISTORY IN THE NEIGHBORHOOD

THE COHEN RESIDENCE

Although Audubon Place and Montrose Boulevard, with their esplanades and generous lots, were designed to accommodate the mansions of Houston's burgeoning upper-class, some of our most famous residents chose to live on the quiet, tree-lined streets in between. Among these were George and Ester Cohen, who bought the house at 607 Kipling shortly after their marriage in 1921. George Cohen was president and general manager of Foley's, our city's first fully airconditioned store. He was born in Galveston, in 1885, and worked in his father's store as a boy. Much of his formal education and early business experience was acquired in New York City. In 1917, Cohen gave up a flourishing window trimming service and moved to Houston. With his father, he purchased the Foley brother's store at Main and Preston. Under Cohen, Foley's had become, by 1927, a nine story department store, the city's largest, rising story by story, at night, so that business could continue during the day. According to Cohen, Foley's "made money each and every year despite all of the economic ups and downs." Even during the depression, Foley's solvency was secure.


In addition to his retailing empire, George Cohen was active in other commercial enterprises involving petroleum, cattle, timber, and real estate. He served on the Municipal Aviation Committee, which, with the help of Captain Eddie Rickenbach of Eastern Airlines, put Houston on the air map, and he was a principal organizer of the famous 1928 Democratic Convention in Houston, along with such notables as Jesse Jones, Will Hogg, Will Clayton, and W. S. Farish. The Cohens were major supporters of the Museum of Fine Arts and the Houston Symphony, and they were active members of the River Oaks Country Club and the Congregation Beth Israel of Houston, the oldest Jewish religious organization in Texas.


To devotees of local architecture, however, George Cohen may best be remembered for the lovely Cohen House, donated to Rice University in 1927, in honor of his parents Agnes Lord and Robert I. Cohen. This picturesque building serves as a faculty club, and it incorporates Byzantine elements similar to those employed in the original buildings at Rice. It is truly a sensitive testament to filial devotion. The gift was announced on his mother's 70th birthday, the building was dedicated on his father's 71st birthday, and George Cohen was personally involved in all phases of planning and construction. He even accompanied the architect, William Ward Watkin, to Chicago to select the furniture and accessories for the interior, which includes embellishments by famed woodcarver Peter Mansbendel.


The relationship between George Cohen and William Ward Watkin would endure. Watkin came to Houston to supervise the construction of the first buildings at Rice and later became head of that university's department of architecture. He was one of the best of an elite group of traditional architects working successfully in Houston. In addition to his work at Rice, Watkin developed the plan for the Broadacres subdivision, and he designed the 1929 neoclassical wing of the Museum of Fine Arts, the Palmer Memorial Chapel, and the elegant homes at 1318 North Boulevard (for Brian Brewster Gilmer), #2 Sunset (for H.C. Wiess), #11 Shadowlawn Circle (for Dr. E. M. Armstrong), and #1 Longfellow Lane (for F.A. Heitmann). In 1938, Cohen commissioned Watkin to coordinate a series of renovations on the house at 607 Kipling. Watkin ultimately transformed this once modest residence into a mini-mansion that now includes a fantastic Art Deco room in the shape of a ship's interior.

In 1944, George Cohen sold Foley's to the Federated Department Store chain, and in 1947, the store was moved to its present site at 1100 Main. Its opening generated tremendous excitement. According to HOUSTON magazine, the new store, designed by Kenneth Franzheim, was the first complete department store to be built in the country since 1929. It incorporated numerous innovations, including a dramatic, vertically divided stone and aluminum exterior bathed in indirect neon, a 5-story parking garage, connected to the main building by an underground tunnel, and a stylish, distribution-efficient, climate-controlled interior. Judging from the enthusiastic commentaries of the day, no one could possibly have imagined that the new Foley's was to be the last of its kind in downtown Houston.

The Cohens lived at 607 Kipling until 1970. Following George's death, Mrs. Cohen, known affectionately as "Sister" to her many friends, sold the house to Kenneth Peden, a relative of Houston hardware mogul, E. A. Peden.



Bylaws Update

The set of new Bylaws submitted by the Bylaws Committee has been revised following the March meeting, approved by the Executive Committee, and will be presented and voted on at the April 1 meeting.

Hearing on Disposition of Property at 708 West Alabama

A hearing is scheduled at 9:00 a.m. on Tuesday, March 30 at the Southeast Police Station located at 8300 Mykawa to review the status of the abandoned property at 708 W. Alabama, the blue house across from the Stop-N-Go. As you know this property has been vacant and open to the public for several months. All concerned persons in the community are welcome to be present at the hearing. There is a section of seating reserved for neighborhood representatives and interested persons. The Key Map indicates that 8300 Mykawa is about 3 miles south of South Loop 610 (west of Hobby Airport).

Neighborhood Protection Presentation

Todd Cooper and Nick Toparcean, Division Managers from the Neighborhood Protection Department of the City of Houston, presented an overview of the responsibilities of the Neighborhood Protection organization at the March APA meeting. Under the Neighborhood Protection program, a team of inspectors is assigned to zip code areas of the city to enforce the City of Houston Dangerous Building and Neighborhood Ordinances (Chapter 10, Code of Ordinances). They watch for dangerous buildings, overgrown weeds, trash and other problems.

In addition, Neighborhood Protection operates a hotline Monday - Friday from 8:00 a.m. to 5:00 p.m. The hotline number is 525-2525. Call this central number to report problems and violations. When you call, it is important to give the operator the correct address of the property, and be

can easily check on the status of the problem.

APA extends a hearty thanks to Todd and Nick for informing us about Neighborhood Protection and for answering all of our questions. We also appreciate their help in reporting the vacant and open building at 708 W. Alabama.

In addition, the City is working on an expanded abandoned vehicle ordinance that will not only apply to vehicles left on the street, but will extend to vehicles on private property. Remember that inoperable vehicles or vehicles without current license tags that are left on the street will be removed by the City. The City is taking a more active roll in citing vehicle violations as part of the Neighborhood Protection Program. Abandoned vehicles may be reported by calling 525-2525. Information concerning towed vehicles may be obtained at 221-0777.

Beautification of the Audubon Place Esplanade

It's time to improve the appearance of the esplanade that runs the length of Audubon Place from Hawthorne to West Alabama. John O'Donnell, Chairman of the Beautification Committee, is heading up this project. The enclosed letter describes the project in detail. Beautification of the esplanade and providing for its ongoing maintenance will benefit everyone in the neighborhood. Both funds and volunteers will be needed. Let's all add our support to John's and help to enhance the beauty of the neighborhood!

Special Recognition

Our very sincere thanks goes to Greg and Elisa Phelps Gray who have provided us with a neighborhood recycling program for the past 2 years. Their garage area at 704 Marshall was taken over by aluminum and glass. They personally sorted, washed, and hauled, 400 to 500 pounds of glass at a time to the Westpark Recycling Center. Overall nearly 3 tons of glass has been recycled as a result of the Gray's hard work and perseverance. It's hard to realize the incredible amount of selfless dedication necessary to manage such an undertaking. We are deeply grateful for their contrisure to get a project number assigned to your call so that you bution on behalf of APA to the environment.

APA Sound-Off

As owners and/or residents of properties on Roseland and intersecting streets, we have experienced many difficulties and inconveniences for years due to the proximity of our residences to Grif's Inn. We recognize that even residents located four or five blocks away also may have experienced some difficulty from time to time as a result of activities at Grif's. However, it is clear that the closer one's proximity is to Grif's, the greater the impact of these problems becomes. All of us can recognize the fact that we tend to be most concerned about the problems that we are confronted with in our immediate vicinity. The history of our civic association is replete with examples. Residents of Audubon place a high priority on the condition of the esplanade. Residents of Marshall whose property backs up on W. Alabama properties are very concerned about the condition of buildings on W. Alabama. Residents along Hawthorne have been frustrated and concerned about the placement of dumpsters on sidewalks. Residents of Harold had concerns about an abandoned building in their block. While these are all issues that affect the neighborhood at large, their impact is primarily on the residents who must live with them day after day. All of these problems represent boundary violations for the residents who must deal with them daily. Yes, there are issues that affect all of us equally, and serve to unite us. Crime/security immediately comes to mind, as well as recent efforts to institute zoning to protect the residential character of our neighborhood. However, one of the truly difficulty tasks that any civic association faces is the task of dealing with the problems that only parts of the association are experiencing. It is our belief that the best and most functional approach to take is one of inclusion. Inclusion is an easy word to say, and a difficult thing to do. To make inclusion a reality, as individuals we may be asked to support things that we have no strong desire to support, or may even oppose. The challenge is to work to include as much of everyone's agenda as humanly possible. As an association, we should always have great concern when any policy we consider might result in individuals perceiving that they are being excluded.

Many, though not all, residents of Roseland have felt excluded in the past by the Audubon Place Association. The feeling of exclusion has resulted from the perception that the civic association does not support our efforts to reduce the negative impact on our properties that result from some of the activities at Grif's Inn. It is possible that many residents of the Audubon Place neighborhood do not know or understand what we have been experiencing, or what it is that we are trying to accomplish.

What have we experienced on Roseland and surrounding streets as a result of some of the activities of Grif's Inn? The following is a partial list:

Frequent occasions of amplified noise that can be clearly heard inside our homes, often after 10:00 p.m.

Urination on our porches and doorways by patrons, particularly after large events.

Uprooting of plants and destruction of private property, especially during special events.

Beer bottles and refuse left behind by patrons, especially after special events.

Our driveways blocked by patrons of the establishment.

Acts of fornication in the parking lot of the establishment.

Porta-cans in full view left for weeks after special events (and frequented by vagrants).

Chartered buses left idling on Roseland, emitting noise and fumes, and partially blocking the street.

Barricades erected with City permission but without police officers present as required by the permit.

Threats and verbal harassment from patrons directed at residents, especially during special events.

Some no doubt, believe that our goal is to close down Grif's Inn. We state without qualification that it is not our goal to close Grif's Inn. What then is our goal? We have two basic goals: One, that the boundary violations we have experienced be reduced through strict compliance with all city ordinances. Two, that the owner of Grif's Inn demonstrate sensitivity to the rights of the residents when special events are held that are legal, but constitute a nuisance for people living nearby. We recognize that the first goal is one that is fully in our power to control. We also recognize that while we can work towards achieving our goals without the support of the Audubon Place Association, our efforts will be more effective and have greater results if we have the support of our civic association. At the very least, we ask our civic association to understand and have empathy with our situation (as we should also have understanding and empathy for situations faced by other parts of the neighborhood) and maintain neutrality in the issue if it can not actually support us.

Concerning the recent decision to participate as a civic association in the St. Patrick's Day event at Grif's Inn, we understand the desire expressed to take advantage of the offer of money for our organization. We do not oppose the right of Michael Griffin to make contributions to the Audubon Place. However, we ask all members of the association to be aware that in the past, our efforts to improve the situation on our streets were often hampered by Mr. Griffin's assertion that he had the support of the Audubon Place Association. This can have a great impact on city officials in determining whether to actively enforce city ordinances.

We would ask all residents to ask themselves these questions:

How would I feel about the events listed above happening on my block?

Can I ask my neighbors to support my concerns if I am not willing to consider support of theirs?

If we needs funds, is there a way of raising them that does not work to alienate a portion of the neighborhood?

At the March meeting, someone stated that the civic association acts primarily by consensus. We support this concept. Webster's defines consensus as "agreement in opinion, testimony, or belief." It is clear from the vote taken that there is not consensus about participating in Grif's event as a civic association. We remind all members that we are only asking that the participation not be done on the part of the civic association. We support the right of individual members to participate, as well as to donate proceeds from their efforts to the civic association. We are all challenged to seek a common ground on this very divisive issue. As residents concerned about the impact of Grif's Inn on our lives and property, we are willing to seek that common ground.







SECURITY

Newly appointed Security chairperson, Jerry Sebesta, will represent APA at the monthly Neartown Association security meetings and will monitor the security patrol efforts in conjunction with WAMM Civic Association. Further activities will complement efforts of PIP (HPD's Positive Interaction Program) and support Valerie Peiser who is APA's PIP representative as well as co-chair of Central Patrol Division PIP. Jerry will also maintain close liaison with Sergeant Chuck Jackson at the HPD Neartown Community Storefront, 802 Westheimer. To ensure that APA receives up to date crime and security information Jerry plans to meet with Sgt. Jackson weekly and is already online with HPD's FAX ALERT PROGRAM.

Security Highlights:

In a recent letter issued by Police Chief Sam Nuchia, it was noted that Houston has had an 18% drop in the crime rate during 1992 and a double digit drop in almost every category of crime in neighborhoods throughout the city. Although this trend continues, the crimes being committed are more violent and the randomness of them is frightening. Chief Nuchia has issued a challenge to our community to be involved and work together to turn this new trend of violent crime around. Citizens must be alert and report activities that they feel might in any way jeopardize the security of their neighborhood. Be active in this process by calling HPD at the following phone numbers:

US 59 HOV LANE - PUBLIC HEARING

On Tuesday May 11, 1993, at 7pm the Texas Dept. of Transportation will hold a public hearing at River Oaks Elementary, 2008 Kirby, to discuss the extension of the HOV lane on the Southwest Freeway from Shepherd to W. Alabama. The project includes replacing the Hazard, Woodhead, Mandell, and Dunlavy bridges, retaining walls, noise barrier walls, and construction of auxiliary lanes. All interested persons are invited to attend.

STEDMAN-WEST CENTER

The Child Development Center of Houston-Galveston Pschoanalytic Institute (CDC) has announced plans to build the Stedman-West Center at 900 Lovett Blvd. (next to LaMora). Due to open in the Fall of 1994, the Stedman-West Center is a therapeutic nursery school supporting the healthy emotional development of pre-school children and will provide psychoanalytic services for children through the CDC Educational Outreach Program.

708 WEST ALABAMA

On March 30, 1993, the Houston Hazardous Building Commission held a hearing with respect to the property at 708 W. Alabama. The Commission entered an order that the owner had ten days to secure the property and 30 days to repair or demolish the property. The building has been secured. However, the building is owned by an absentee owner and the lienholder is faced with having to take back the property.

Neighborhood Protection has been extremely helpful in working to resolve this matter. Frank Crawford, the City Inspector assigned to the neighborhood has stated that he will follow up on the applicable deadlines for action on the property. However, because of the ownership problem and the state of the building, ultimate repair or removal of the building will probably be a long-term project.

ZONING UPDATE

The Zoning Ordinance is now in the hands of the City Council Committee, the final step prior to presentation to, and adoption by, the full Council. Passage by City Council seems assured at this point, and is expected sometime next month.

Insiders say small refinements are being made to the ordinance, but that the general tone of the document remains the same as that passed by the Planning and Zoning Commission last year.

Voters will be granted the opportunity to express their approval of the ordinance by referendum, tentatively scheduled for November. As might be predicted, a coalition of developers and assorted strange bed-fellows is organizing to oppose any sort of land-use controls, while various civic organizations are coalescing their assets to support the ordinance. RECYCLING

The latest word from the City recycling desk is that all neighborhoods waiting to be added to the recycling program will have curbside pickup by the end of this year! What does this mean? Those of us who already recycle will have an incredible convenience. For those who don't, curbside pickup may be the motivation they need to just do it.

The City just added magazines and phone books to its list that already includes tin, glass, aluminum, paper, and plastics. We can recycle just about everything except organic waste. This is where we can really do a simple task in our own backyards. It's called a compost pile! The Brookstone Catalog (1-800-926-7000) has many do it yourself compost kits that can get you started. I will discuss more details and ideas on composting in upcoming newsletters.

Have you ever wondered what happens to all the plastic waste we recycle? It is made into lumber! National Waste Technologies makes synthetic lumber from recycled plastics. NWT receives between 100,000 and 150,000 lbs. of plastic each week from 11 municipalities on Long Island, NY. This 100% recycled plastic from grocery bags to traffic light signal lenses can be made into several products. Some uses are park benches, picnic tables, boardwalks, home decks, and highway cones. These products are guaranteed against rot, termites, ants and splinters. I encourage everyone to support those manufacturers who use recycled products to make their packaging.



CRIME ON THE REBOUND

Since APA first implemented its Security Patrol Program in 1991, we have seen a dramatic drop in crimes committed in our neighborhood. Many of us who once feared to leave the safety of our homes, somehow feel safer, and once again able to enjoy an evening stroll, a visit with the neighbors, or even a trip to Walgreen's after dark. Our assertive and determined efforts to rid our streets of crime was especially evident back in 1990 when an Eye Witness News segment depicted APA as "a neighborhood fighting back." According to 1993 statistics derived from HPD reports, it looks as if our low crime rate is unique in the community. APA Security Chair, Jerry Sebesta calls us "an island in the storm." However, while crime has dropped off, contributions to our security fund have equally been waning and the fund will soon be exhausted unless we do something about it. There is a very real possibility that our storm-free status could be short-lived. In the past, we have rallied to the cause and it has paid off. Let's continue to prove we are united against crime by supporting our Security Patrol Program.

ALLEY CLEANUP - SATURDAY, JUNE 5

This is the opportunity you have been waiting for!! Two large trash containers will be located in our neighborhood, one on Stanford and one on Audubon on Friday, June 4 by the City of Houston's "Adopt-A-Container Program" group. The containers will be removed on Monday, June 7.

NEIGHBORHOOD TRAFFIC PROJECTS

Eve Beasley, President

The City of Houston has passed an ordinance that provides a mechanism for a neighborhood to work with the City to control traffic patterns within the neighborhood. The concept is to evaluate, plan, and design modifications of residential traffic circulation for the protection and enhancement of neighborhoods as well as crime reduction through the utilization of the Crime Prevention Through Environmental Design (CPTED) concepts. The plans include possible one-way street entrances and exits, street closures (barricades and permanent), narrowed street entrances, entrance islands, chicanes, diagonal directional islands at intersections and perpendicular directional islands at intersections. The process is started by notifying the Mayor that a neighborhood street project is needed. The City has prepared a Manual describing the program. If anyone is interested in reviewing the Manual or looking at possibilities for neighborhood streets, please contact John Unger at 524-8725.

NEARTOWN ASSOCIATION ACTIVITIES

Neartown Association serves as an umbrella group for some 20 area civic and professional organizations. This extended support base gives Neartown strong name recognition at City Hall and as a result it is usually the first to hear about matters impacting the community. The Neartown Area Presidents Council provides a network for information dissemination throughout the Montrose area. Recently, Eve Beasley along with Jack Rose of Castle Court were appointed to serve on the board of Neartown as representatives of the Presidents' Council. Ed Kopinitz is the Vice President of Neartown

and serves on its executive board. Neartown meets on the 4th Tuesday of each month at Bering Memorial Methodist Church at 7:30 p.m. Annual dues are \$15. For more information call 529-1110.

Neartown in conjunction with The City of Houston and National Commerce Bank has forged an alliance to target improvements for the Neartown/Montrose area. The cooperative effort will begin in the Avondale neighborhood. National Commerce Bank has donated \$10,000 for Phase One landscaping and the possible construction of an entrance-way at Westheimer and Bagby. NCB is also marketing home improvement loans to qualified owners in the targeted area.

Neartown is also exploring the organization of the Neartown Community Development Corporation.

HERITAGE PROJECT CONSIDERED

The Audubon Place Association is considering undertaking a project to accumulate, dispense, and record various aspects of the history of the Montrose Addition. With every passing year, portions of our written, architectural, and photographic history are lost. Of greater import is the salvation of oral history. We still have with us children and grandchildren of some of the original owners of homes in the area; people who have personal experiences, as well as stories they remember from their parents, to relate. In another generation this original memory will no longer be available.

Preliminary discussions are leading toward a three-part project:

- 1. A lecture series. This would be a series of two perhaps three audio-visual programs in which several individuals would review aspects of the history and development of the area. We envision a mixture of economic and social history, architecture, and gossip, generously laced with period and current photographs.
- 2. A home tour we have only a few homes still in a relatively untouched state, but many of our houses have been imaginatively and successfully redone, and our hope is to encourage others to do the same - and raise a few dollars in the process.
- 3. A video documentary of development, current state, and perhaps ideas for preservation and stuture development of the area, with interviews of former and current residents. This would be for sale to individuals, but a shorter program edited from this video may be produced for airing on television.

Our goals are several. We hope, of course, that it will be a fund raiser. We hope, equally, that it will improve the perception of, and interest in, Montrose. Our neighborhood has too often been saddled with an undeserved negative image. One of the goals will be to refute this. The most important aspect, though, for many of us is to record a disappearing heritage for posterity.

A committee has been formed to develop this project and is requesting input. If you think its a good idea, let the committee members know. If you have suggestions to propose, or talents to contribute, let them know. If anyone knows about the history of your particular home, or knows former residents who might be contacted for interviews or old photographs, certainly give the committee that information.

SECURITY

SECURITY PATROL

APA in conjunction with WAMM Civic Association maintains a security patrol that provides car patrols in the neighborhood. Patrol days and times are varied during the month so as not to create a definite pattern. The patrol is made possible by contributions to the security patrol fund.

SECURITY HIGHLIGHTS

Although it was reported last month that Houston overall had an 18% decrease in its crime rate in 1992, it appears that recent figures released on crime statistics for Neartown as a whole still show that this area is very vulnerable to crime and criminal activity. Most of our bordering neighborhoods are reporting rising crime with auto vandalism and prostitution heading their lists. There was a rape in Westmoreland, on Garrott, April 27, and a double rape on Hazard, April 29.

In contrast, during April APA had the lowest crime month in years with three auto thefts reported for the month. We are in essence an island in the storm. Although we have seen a decrease in crime in the neighborhood, criminals move from areas of high activity to areas of low activity. As high activity areas become more aware and increase patrols, the criminals move to other areas. We must not let down our guard. Be aware, be cautious, and report all suspected criminal activity no matter how insignificant you believe it to be. Remember we have a neighborhood patrol that works to keep the neighborhood safe. Please continue to support the patrol with your donations!

APA actively participates in the City's P.I.P. program and receives monthly reports on the City's efforts to fight crime, important area concerns, and a listing of crimes committed in the area. In March, there were two robberies (3/04/937:10 a.m., 600 blk. W. Alabama and 3/22/9311:50p.m., 3500 blk. Montrose); one burglary (3/19/93 5:00 p.m., 700 blk. W. Alabama); and four auto thefts (3/03/93 11:00 p.m., 600 blk. Harold, 3/17/ 93 5:30p.m. 600 blk. Marshall, 3/17/93 900 blk. Hawthorne, and 3/18/93 12:30 a.m., 600 blk. Marshall) reported in the general area.

A Reminder - While it is often more convenient to park your car in the street, a car parked in a driveway is less likely to have a window broken, to have a radio stolen, or to be stolen itself. In addition, by keeping the streets clear of cars at night, it is easier for law enforcement to tell whether a particular car belongs in the neighborhood.





BIG OIL COMES TO AUDUBON PLACE by Ed Muraski

By 1920, the Abercrombies had come a long way from the days they operated a small dairy on land leased from George Hermann. At the age of seventeen, with his father's health failing and a dozen family members to support, J. S. Abercrombie left the dairy business to seek a fortune in the legendary Gulf Coast oil fields. Now, at the ripe age of twenty-nine, Jim was not only head of his own independent drilling company, he was also president of Cameron Iron Works. Confident that his success would continue, Jim purchased the new residence at 3402 Audubon Place.

For the Abercrombie clan, the house was ideal. It was large, comfortable and situated in a fine, friendly neighborhood, with Congressman Joe Eagle next door, and Roy Huffington down the street. It would be home for Jim, his grandmother, and his brothers and sisters for many years to come. In fact, some would continue to live there even after they were married, in a setting presided over by their sister and surrogate mother, Miss Annie, who, in 1920, was also working for the family drilling company, along with everyone except brothers Will and Bolling.

Suddenly, on a day in March, 1922, Jim Abercrombie's luck appeared to change. Following two unsuccessful attempts to workover a well in the tricky Hull field, the well blew. Jim completely lost the well, his best rig, and almost his life. However, his prevailing common sense and far-ranging imagination enabled

him to turn this financial disaster into opportunity. He recognized that uncontrolled well pressure was an industry-wide problem, and he sketched the original plan for the famous Cameron blowout preventer, which would eventually be used to tame most of the deep oil wells in the world.

Following the expansion of Cameron Iron Works, Jim was able to concentrate on drilling. In the fall of 1924, he was approached by an English syndicate with an ambitious plan to develop a large concession in northern Colombia. Although Jim was anxious to work in a foreign country on a project of such magnitude, there were complications. He had just met the charming Lillie Frank of Lake Charles and planned to marry her. In addition, the thrust of the newly organized J.S. Abercrombie Company was finding and developing oil wells of its own. Possessed by a life-long inclination to keep his family together, Jim decided to discuss the situation with his brothers and sisters, who were also substantial shareholders, and with Lillie, who fitted naturally into the family group on Audubon.

Predictably, during a holiday visit by the Frank sisters, he was advised by all to seize the opportunities that lay before him. So on May 8, 1925 Jim and Lillie were married, and following a brief honeymoon in Kingston, Jamaica, they set sail for Columbia. The Columbian project lasted until early 1927, and after returning to Houston, Jim, Lillie, and infant daughter Josephine, took an apartment at the elegant Warwick Hotel. The rest of the family remained at 3402 Audubon Place, except for sister Vinnie, now married to Max Rotholz, and brother Bolling and his wife.

During the 1930's Jim Abercrombie achieved his greatest accomplishment as an oilman - conquering the high pressure Old Ocean Field. He also purchased the stunning Greek revival mansion at 2221 River Oaks Boulevard. Eventually the brothers followed suit and purchased residences of their own, leaving only Miss Annie, Vinnie, and Max, at the old home. However, the Abercrombie clan continued to gather every Sunday at 3402 Audubon Place for the traditional family dinner. Now in her teens, Josephine began to display a love for horses and much skill as a horsewoman. Her passion would soon lead to the founding of the renowned Pin Oak Stables.

By the summer of 1946, Jim Abercrombie had worked himself out of a job. Responding to an offer by Luther Cleveland, the shareholders of J. S. Abercrombie agreed to sell their holdings in Old Ocean for a staggering \$54 million. Although the veteran oilman would continued his associations with the industry for several years, he and Lillie were free to devote their energies and their vast fortune to numerous philanthropic interests, including the Texas Children's Hospital. During the next twenty years, Miss Annie, one of Houston's first women executives, was also free to concentrate on her own enterprise, The Paris Shop, which specialized in exclusive ladies apparel and was located for a time at 3229 Miliam. Miss Annie was to be the last family member to reside at 3402 Audubon. In 1957, with the Montrose Addition in decline, she closed the house and moved in with Vinnie and Max at 4607 W. Alabama. After almost four happy decades, the old Abercrombie residence fell silent. It remained vacant until 1966, when it was demolished to make room for an apartment building.

For Jim Abercrombie, the end came on January 7, 1975. He died at home during his eighty-fifth year, just three years after losing Annie and Vinnie. He was survived by only three of his many siblings, and within six months his beloved Lillie had also died. Both are buried in Glenwood Cemetery. Their only daughter,

Josephine, along with her two sons, George and Jim, remain in control of the Abercrombie holdings.

Among Houston's many success stories Jim Abercrombie is truly unique. Although he made numerous fortunes during his lifetime, his loyalty to his family, his business associates, and his community will, alone, sustain a much envied reputation.



A Walgreens Superstore in Your Future?

For those in the neighborhood who do not know, the building on the corner of Montrose and Hawthorne is being demolished so that Walgreens can develop the entire 3300 block of Montrose between Lovett and Hawthorne as a Walgreens Superstore. The existing store at Harold and Montorse is apparently one of the most profitable stores in the entire Walgreens chain. The new store will be approximately 17,500 square feet and will be set in the middle of the block. There will be parking for 100 cars in the front and on the sides with perimeter shielded lighting.

Walgreens has been in contact with the City Planning and Development Department to discuss neighborhood concerns with respect to safety, aesthetics, and traffic control. Walgreens plans call for hedges and trees surrounding the property with a sprinkler system installed. Construction plans call for a building of materials better than regular with slight alteration of the exterior to accommodate the building's location in a traditional neighborhood.

The current proposals for signage are not optimum. The City Planning and Development Department has requested less extensive signs. However, since the proposed signs apparently meet the City's sign requirements, change in this area may not be forthcoming. In addition, the delivery entrance is proposed for the corner of Lovett and Roseland. This raises a number of concerns primarily with respect to increased traffic on Lovett and Roseland for delivery vehicles.

No plans have been announced for the old Walgreens' store.



Security -

At the September meeting there was a substantial discussion concerning the direction that the neighborhood security program should take. There has been growing dissatisfaction expressed by some residents concerning the current arrangements. For the past year APA has shared expenses with the WAMM association for an off-duty HPD officer to patrol the two neighborhoods for approximately 32 hours per month or eight hours per week. Expenses include salaries, fuel and maintenance for the car, and liability insurance. To maintain this program a significant outlay is required to cover the next year's insurance.

Sentiment has been expressed that APA should explore a "Citizens on Patrol" program.

Other alternatives are to join the constable's patrol program or wait on HPD's subsidized officer program to become a reality. A Citizens on Patrol program is less expensive but requires a considerable investment of resident's time to make the program work. The constable's program is considerably more expensive. APA may be able to join with other surrounding associations, such as Westmoreland, in order to provide sufficient funding and volunteers.

If you have ideas concerning security or are interested in becoming involved in a Citizens on Patrol program, pleas come to the October meeting. We hope to have a guest speaker from East Montrose Citizens on Patrol group and possibly Lt. Larry Lakind to discuss alternatives. Stay tuned for more details.

The HPD Positive Interaction Program area crime report for August 1993 shows no reported robberies in the neighborhood. However, there were three auto thefts (8/10/93 7:19 p.m. 900 blk. They have budgeted for street closure, sanitary portable toilets, and trash receptacles and pick-up, and the city is requiring that they provide security. 

Christmas is just around the corner and we can anticipate an increase in attempted burglaries and other crimes. Diligence is demanded. Report all crimes and watch out for your neighbors.

An arrest has been made in the murder at Commonwealth and Hyde Park. Juveniles were involved and robbery appears to have been the motive.

If you find capped bottles of any kind in your yard or the area, do not remove them unless you can visually verify that they are empty. If you believe that they contain the chemical makings of bottle bombs, dnot hesitate to contact the HPD bomb The incident on sauad. Fairview (west of Shepherd) earlier this month was not the first and although the people responsible may believe that these incidents are pranks, the bombs can be lethal. The police believe that the Fairview bombs were dry ice.

Audubon Place dodged a bullet with the recent tornado, but other areas were not so lucky. There was damage in the 500-600 blocks of Branard, Colquitt, and Sul Ross, as well as Westmoreland place.

Houston Recycles

Audubon Place is not yet part of the Houston recycles program, which already covers 46,000 homes in the city. Between November and February, Houston Recycles will be adding 60,000 homes to the green box pick-ups. When will Audubon Place be added? A good question

Neighborhoods will be added first if they are contiguous to existing recycling areas. The city is seeking to optimize their equipment and staffing in this program.

One new area will be added to the program every other week during the fourmonth phase-in. Residents will be notified about 3 days before their first pick-up. The green bins will be delivered at that time, with instructions inside. the pick-up day will coincide with one of your regular trash days. The neighborhood recycling chairperson, Karen Bernstein, Association President, and/or your block captain (see below) will know about two weeks ahead of time).

Houston Recycles will take the following: newspaper, magazines, glass containers, some plastic (#1 and #2), cans, motor oil (if properly contained).

They will not take: wide-mouth plastic tubs, broken glass, empty motor oil containers, grocery bags of any kind. If you put out the wrong stuff, it will be left behind. In the beginning you will see a yellow sticker identifying the wrong items.

The brochure that you will receive with your green bin will have all this information in it, plus a recycling hotline phone number.

Special Information:

Audubon Place Association will have block captains for Alabama, Marshall, Kipling, Harold, Hawthorne, and Audubon (volunteers needed: please call Karen Bernstein, 526-4967). The block captains can answer any questions that you have. They will also carry extra green bins to replace any that are stolen. Block captains will be your first source of information.

If you live in a townhouse that does not face the street, you may not be included in the program. If you normally have city trash pick-up, that's a good sign. You can call your block captain to find out if you will be included. Apartments with more than 8 units will not be included.


